



Terms and Conditions: Waiver of Liability and Release

I, the undersigned participant/parent or guardian of the participant, recognize and acknowledge that activities at “THRIVE Kids”, which includes physical and fitness activities which involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death and property damage which might result from participant action, inaction, negligence of others, rules of play, or the condition of the premises or any equipment used thereon. Risks include, but are not limited to, broken bones, torn ligaments or other injuries as a result of falls; falls, hits or other harm from equipment; falls, slips or other harm caused by uneven surfaces; medical conditions, resulting from physical activity; and damaged clothing or other property. Further, I understand that there may be other risks not known or reasonably foreseeable at this time and that such risks shall be assumed by the undersigned. In my absence, I authorize the instructor or coach for THRIVE Kids, to call for emergency rescue services for the participant should they be necessary in the case of injury or suspected injury, or during the times that the above named individual is participating in an activity with THRIVE Kids. I authorize the attending physician at the hospital to administer necessary emergency medical care to the above individual upon arrival at the hospital. I will accept responsibility for the payment of any and all treatment provided therein including emergency rescue services. I certify that the above named is capable of participating safely in the activities with THRIVE Kids. I understand that the owners of THRIVE Kids do not provide accident, health, or life insurance coverage for the above named participant during program participation. I further understand that I am legally responsible for actions of the above named individual including, but not limited to, any damage to private or public property. I am legally responsible for my own and/or my child’s welfare and actions including personal needs and medical expenses. I agree to indemnify and hold the owners of THRIVE Kids and its representatives harmless from any loss, damage, or injury which may result from me or my child’s participation in activities with THRIVE Kids. This release of liability and indemnity applies equally to losses, damages, or injuries caused or alleged to be caused in whole or in part by the negligence of the owners of THRIVE Kids. I further agree to release, waive and discharge, and covenant not to sue the owners of THRIVE Kids for any claims, demands, or actions whatsoever arising out of any damage, loss, or injury incurred on or to me or my child as a result of my participation or my child’s in activities at THRIVE Kids. This release of liability and indemnity applies to me, the undersigned, or my child, as well as any personal representatives, assigns, heirs and next of kin. I have read and fully understand the effect of the relinquishment of the rights that I hereby waive.
